I am directed to state that it is proposed to fill up the post of Secretary in the Bureau of Energy Efficiency on deputation basis from the officers of Central or State Governments holding a post not below the rank of Deputy Secretary to the Government of India in the parent cadre.

- 2. The post of Secretary in the Bureau of Energy Efficiency (BEE) carries the scale of pay of PB-4 Rs. 37400-67000 + Grade Pay of Rs. 8,700 (pre-revised Rs. 14,300-18,300). The officer selected for appointment will be entitled to draw pay/deputation allowance + other allowances as per Central Government Rules.
- 3. The appointment to the post of Secretary shall be made on deputation from amongst officers of the Central/State Government holding a post not below the rank of Deputy Secretary to the Government of India. The Secretary shall hold office for a term of three years, from the date on which he/she enters upon his/her office or, the date of his/her superannuation in his/her parent cadre, whichever is earlier. The term of deputation can be extended where considered necessary up to a period of five years. The selected candidate would be posted in Delhi. He/She can however be posted anywhere in India.
