Ministry of Shipping invites applications for the post of Member (Cargo) in IWAI, NOIDA, U.P. in the scale of pay of Rs.37,400 - 67,000 with Grade Pay of Rs.10,000 on deputation basis.

- 2. Inland Waterways Authority of India (IWAI) is an Autonomous Body constituted under the Inland Waterways Authority of India Act, 1985 for the regulation and development of Inland Waterways for purposes of shipping and navigation. IWAI is currently engaged in developing navigation infrastructure on the five National Waterways. Inland Waterways Authority of India consists of a Chairman, Vice-Chairman and other Members who function under overall supervision of the Chairman.
- 3. Post of Member (Cargo), IWAI is a statutory post created under Section 3(3) of IWAI Act, 1985. As per this section, the appointment is made by the Central Government. The post is not part of the Central Staffing Scheme and is required to be filled up as per criteria fixed by Ministry of Shipping. Ministry has decided to fill this post on deputation basis for a period upto 3 years (as may be determined by the Central Government having regard to the circumstance of each case).
- 4. The Member (Cargo), IWAI will be responsible for:
  - (i) Marketing and Promotion of IWT activities;
  - (ii) Evaluation of IWT promotion Schemes prepared by Technical Wing
  - (iii) Levy of user charges-rendering advice thereon;
  - (iv) Rendering commercial advice to run the organization on business principle
  - (v) The Member (Cargo) shall attend every meeting of the Authority unless prevented by sickness or any other reasonable cause.

- 5. As a Member of Authority, Member (Cargo) will be entitled for free unfurnished accommodation on deputation on deduction of 10% of the salary subject to ceiling on the monthly rental for such accommodation to be regulated in accordance with the rules for the time being in force for allotment of residence or to draw such house allowance as is admissible to the highest category of officers of the Authority.
- 6. All India Service Officers and Officers of Indian Revenue Service, Indian Railway Traffic Service, officers of Central Services or State Road Corporation officers of age less than 55 years as on the closing date of application (20.09.2010) and holding the post at the level of Joint Secretary or suitable for such appointment with experience in transport, traffic development and operations in Public Sector Undertakings will be considered for the post.
- 7. The Cadre Controlling Authorities of the services referred to in the para above and the State Governments are requested to give wide publicity to the vacancy and forward names of suitable and willing officers for consideration for the post.
