I am directed to say that the Institute of Secretariat Training and Management (ISTM), New Delhi proposes to fill up one faculty post of Assistant Director (Accounts) [PB-2 with Grade Pay of Rs.4800/-] by appointment on deputation basis from amongst suitable and eligible officers working under Central Government. The officers selected shall be entitled to 'training allowance' on their basic pay as may be determined by the Government of India from time to time. [At present training allowance is 15%]. The eligibility conditions, qualifications and experiences required for the post and other details are given in Annexure-I.

Applications of only such officers/candidates will be considered as are routed through proper channel and are accompanied with (i) Bio-data (in quadruplicate) in the proforma given in Annexure-II (ii) Attested photocopies of ACRs/APARs for the last five years(ACRs/APARs to be attested by an officer not below the rank of Under Secretary) (iii) Vigilance clearance (Annexure-III) (iv) Statement giving details of major or minor penalties imposed on the officer, if any, during the last ten years as given in Annexure-IV (v) Integrity certificate(Annexure-V) and (vi) Cadre Clearance.

Note: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January,2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this
