Applications are hereby invited for selection to the **two(2)** posts of Member, AERA. The terms and conditions for selection to the post of Member, AERA are as under:

1.	Scale of pay	Pay Band 'HAG' in the scale of Rs.67,000/- (annual increment @3% - 79,000/-)
2.	Terms and Conditions	The Member will be governed by the terms and the service conditions as laid down in the Airports Economic Regulatory Authority of India Act, 2008 and Rules made thereunder. The Member shall be a whole-time Member.
3.	Essential Qualification and Experience	Persons of ability and integrity, having adequate knowledge of, and professional experience in, aviation, economics, law, commerce or consumer affairs: Provided that the person who is or has been in the service of Government shall not be appointed as a Member unless such person has held the post of Secretary or Additional Secretary to the Government of India or any equivalent post in the Central or State Government for a total period of not less than three (3) years.
4.	Tenure	The Members shall hold office for a term of five years from the date on which he enters office, but shall not be eligible for re-appointment: Provided that the Members shall not hold office, as such, after he attains the age of sixty-two years

OFFICE MEMORANDUM

Subject: Selection for the post of Member in the Airports Economic Regulatory Authority (AERA) – reg.

The undersigned is directed to refer to Cabinet Secretariat's Note [No.8-27/2011-CS (A)] dated 25.04.2012 on the above mentioned subject and to say that AERA Act, 2008 provides for the appointment of two Members in the Authority by the Central Government on the recommendation of a Selection Committee under the chairmanship of Cabinet Secretary, and comprising of Secretary, Ministry of Civil Aviation (MoCA), Secretary, Department of Legal Affairs, Secretary, Ministry of Defence and one expert to be nominated by MoCA as Members.

2. In regard to re-advertisement of one post of Member, AERA, it is submitted that in pursuance of the provisions of the Act, this Ministry had, from time to time solicited directions/guidance from the Committee for initiating action for selection to the post of Member, AERA. For instance, concurrence of the Cabinet Secretariat was sought by the Ministry for re-advertising the post when Screening Committee did not find any suitable candidates. The Cabinet Secretariat vide note No.8-7/2010-CS (A) dated 19.08.2011 directed this Ministry to re-advertisement of the post.

3. In pursuance of above, the post was re-advertised and Cabinet Secretariat was apprised of the responses received and a list of shortlisted candidates was also forwarded. The meeting of Selection Committee was first scheduled for 26.12.2011 which was postponed to 09.01.2012 and subsequently to 28.02.2012 which was also postponed. As the process for selection had been initiated on the directions of the Cabinet Secretariat, which could not get completed and in the meantime a decision has been taken in this Ministry to re-advertise the post, concurrence of Cabinet Secretariat is sought for abandoning the process and re-advertise the post.
