## Office Memorandum

Essential: Diploma in Electrical Engineering with three years experience in construction and maintenance including designing, estimating contracts, supervision etc of electrical installation, lifts, sub-station equipment, generating sets, telephone exchange, uninterrupted power supply system, air conditioning etc.

Desirable: Degree in Electrical Engineering from recognized University/Institution

Note 1:- Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other organization/department of the Central Government shall ordinarily not exceed five years.

Note 2:- The maximum age limit for appointment on deputation(including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of application.

Note 3:- For the purposes of appointment on deputation or absorption basis, the service rendered on regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Commission except where there has been merger of more than one re-revised scale of pay into one grade with a common grade pay/pay scale and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any upgradation.

Note-4: In case, the Junior Engineer (Electrical) appointed in this Department on deputation is being considered for absorption, he or she should have completed five years of continuous service in the grade before the date of absorption.

For Ex-Serviceman: The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall be considered. Such persons shall be given deputation terms up to the date on which they are due to release from the Armed Forces, thereafter they may be continued on reemployment.
