Provided that the person who is or has been in the service of Government shall not be appointed as a Member unless such person has held the post of Secretary or Additional Secretary to the Government of India or any equivalent post in the Central or State Government for a total period of not less than 3 years.
4.	Tenure	The Members, shall hold office, for a term of five years from the date on which he enters upon his office or till he attains the age of 62 years, whichever is earlier.
