**Advertisement for the post of Members of the Airports Economic
Regulatory Authority (AERA)**

The Government of India in the Ministry of Civil Aviation has constituted the Selection Committee for the purposes of selecting Chairperson and other Members of AERA, under sub-section (2) of Section (4) of the Airports Economic Regulatory Authority of India Act, 2008.

2. Applications are hereby invited for consideration of the Selection Committee for making recommendations for selection of 2 Members of the AERA. The terms and conditions for selection to the posts of Members of the AERA are as under:

1.	Scale of pay	Member: Pay Band 4; Scale of pay: Rs. 37400-67000/-; Grade pay Rs. 12000/-. The total minimum monthly emoluments admissible in the pay scale shall be Rs. 72,268 (app.) (excluding HRA).
2.	Terms and Conditions	The Members will be governed by the terms and the service conditions as per Section 4 and 6 of the Airports Economic Regulatory Authority of India Act, 2008 and rules made thereunder. The Members shall be whole-time Members.
3.	Essential Qualification and Experience	Persons of ability and integrity, having adequate knowledge of, and professional experience in, aviation, economics, law, commerce or consumer affairs may apply for the said posts. Provided that the person who is or has been in the service of Government shall not be appointed as a Member unless such person has held the post of Secretary or Additional Secretary to the Government of India or any equivalent post in the Central or State Government for a total period of not less than 3 years.
4.	Tenure	The Members, shall hold office, for a term of five years from the date on which he enters upon his office or till he attains the age of 62 years, whichever is earlier.

4. Those who fulfil the above eligibility criteria and desirous to apply may send their Bio-data by 31.07.2009 in the format attached below.

5. Those who are in Government should apply through proper channel.

6. Applications received for the above mentioned posts in response to the earlier Vacancy Circulars dated 06.01.2009 and 06.02.2009 are treated to have been disposed off and the willing and eligible applicants need to apply afresh.
