AERAAT consists of a Chairperson and two whole time Members.

1.	Scale of pay	Rs. 80,000/- (fixed)
2.	Terms and Conditions	The Member shall be governed by the terms and the service conditions as per Section 19, 20 and 21 of the Airports Economic Regulatory Authority of India Act, 2008 and rules made thereunder namely Airports Economic Regulatory Authority Appellate Tribunal (Salaries and Allowances and Other Terms and Conditions of Service of the Chairperson and Other Members) Rules 2011.
3.	Essential Qualification and Experience	Persons of ability and integrity, has held the post of Secretary to the Government of India or any equivalent post in the Central Government or the State Government for a total period of not less than two years in the Ministries or Departments dealing with aviation or economics or law or a person who is well-versed in the field of aviation or economics or law may apply for the post.
4.	Age limit as on 30.06.2015	Maximum age limit: 65 years
5.	Tenure	The Member shall hold office for a term of three years from the date on which he enters upon his office or till he attains the age of 65 years, or until further orders, whichever is earlier.
