I am directed to say that it is proposed to fill up the following posts, which will fall vacant shortly, in the Central Electricity Authority (CEA), on deputation/short-term contract basis:

- Appointment to the posts of Chairperson and Members in the Central Electricity Authority are made in accordance with the provisions contained in Section 70 of the Electricity Act, 2003 read with the Central Electricity Authority (Terms and conditions of Service of Chairperson and other Members) Rules, 2005.
- 3. In terms of Section 70(4) of the Electricity Act, 2003, the Central Government may appoint any person, eligible to be appointed as Member of the Authority, as the Chairperson of the Authority, or, designate one of the full time Members as the Chairperson of the Authority.

- Section 70 (5) of the Electricity Act, 2003 provides that the Members of the Authority shall be appointed from amongst persons of ability, integrity and standing who have knowledge of, and adequate experience and capacity in, dealing with problems relating to engineering, finance, commerce, economics or industrial matters, and at least one Member shall be appointed from each of the following categories namely:
 - engineering with specialization in design, construction, operation and maintenance of generating stations;
 - (b) engineering with specialization in transmission and supply of electricity;
 - applied research in the field of electricity;
 - (d) applied economics, accounting, commerce or finance.
- 5 In terms of the provisions contained in the Central Electricity Authority (Terms and conditions of Service of Chairperson and other Members) Rules, 2005, no person shall be eligible for appointment to the office of a Member, including the Chairperson of the Authority unless he has held:
 - the post of Chief Engineer or equivalent in the scale of pay of Rs.18400-500-22400(prerevised) or higher post or scale of pay on a regular basis for at least five years under the Central Government or a State Government;

- a post equivalent to that of a post mentioned above, under a State Electricity Board or a semi-Government Organisation or a Public Sector Undertaking or an Autonomous Body or a Statutory Body or a University or an Indian Institute of Technology or an Indian Institute of Management on a regular basis for at least five years; and
- (b) The person would also need to possess a minimum of three years' field experience in the relevant field as defined in sub-section (5) of section 70 of the Electricity Act.
- The duties and responsibilities attached to the posts of Chairperson, Member (Thermal) and Member (Power System), CEA, are given in the <u>Annexure-I.</u>
- 7. The Chairperson and Member shall hold office during the pleasure of the Central Government. Appointment to the post would normally be made for a period of five years, which shall be restricted to the date on which the incumbent of the post attains the age of superannuation. The officer selected will not be eligible for permanent absorption in the CEA. The maximum age limit for appointment to these posts shall be 56 years. The crucial date for determination of eligibility of applicants for the posts will be the closing date for receipt of the applications.
- It is requested that the above vacancies may be given wide publicity amongst the eligible candidates and the particulars of the suitable and eligible serving persons who are willing to be considered and whose services can be spared, may please be forwarded in the enclosed Proforma (Annexure-II) (in quadruplicate) (of applying for more than one post, separate application for each post) together with the following documents/information so as to reach within 45 days from the date of publication of the vacancy in the Employment News/Rozgar Samachar, to the Under Secretary (Admn). Chairperson

Overall coordination and control over the working of the Central Electricity Authority, Administration and all matters relating to legal aspects of the Electricity Act, 2003 and Rules.

Member (Thermal)

Overall thermal power development in the country; updating, development and evaluation of thermal technologies; design & engineering of thermal projects; quality assurance standards and plans; preparation of model documents and standards; thermal projects investigation & ash utilization; monitoring of construction & stabilization of thermal projects and suggesting remedial measures to problems involved; renovation, modernisation and life extension programmes etc.

Member (Power Systems)

Planning and development of Transmission facilities consistent with national power plans; monitoring of rural electrification; Transmission & Distribution loss reduction; studies for the purpose of appraisal of transmission projects; transmission technology development; design & engineering; standardisation and preparation of model document; renovation and modernization of transmission schemes; construction monitoring of transmission projects; inspection of existing electrical installations in Union Territories and Central Government Departments; investigation of accidents on electrical installations and suggesting remedial measures for their minimization and prevention etc.
