CIRCULAR


It is proposed to fill up the post of Member, Appellate Tribunal for Foreign Exchange (ATFE) set up under Foreign Exchange Management Act, 1999. The post of Member carries a pay of Rs.22400-24500/- (Pre-revised)/ HAG scale Rs.67,000-79,000/- (Revised). The service conditions of the post are regulated by the Appellate Tribunal for Foreign Exchange (Recruitment, Salary and Allowances and Other conditions of Service of Chairperson and Members) Rules, 2000.

2. According to the above referred rules, in order to be eligible for the post of Member a candidate has to be or has been, or should be qualified to be appointed as a District Judge. The Member shall hold office as such for a term of five years from the date of entering upon his office or until he attains the age of sixty two years, whichever is earlier.

3. The persons who fulfill the eligibility criteria and are interested to apply for the said post may submit their applications in the prescribed format latest by 11th December 2009. The applications in respect of Government Officers should be routed THROUGH PROPER CHANNEL.
