Subject:-Filling up of the three faculty posts of Deputy Director (Management Services) on deputation basis including armed forces personnel on deputation or Re-employment in the Institute of Secretariat Training and Management, New Delhi – Reg.

Madam/Sir,

I am directed to say that the Institute of Secretariat Training and Management (ISTM), New Delhi proposes to fill up three posts of Deputy Director (Management Services) [PB-3: Rs15,600-39,100/- with Grade Pay of Rs.6600/-] on deputation (for armed forces personnel deputation or re—employment) basis from amongst suitable and eligible officers working under Central Government or State Government and teaching or research faculty from recognized universities of India. The officer selected shall be entitled to 'training allowance' on their basic pay as may be determined by the Government of India from time to time. [At present training allowance is 15%]. The eligibility conditions, qualifications and experience required for the post and other details are given in Annexure-I.

- 2. It is requested that applications (in quadruplicate) of suitable and eligible officers and who can be spared immediately in the event of selection may be sent to SHRI ANIL TRIPATHI, UNDER SECRETARY (Training), TRAINING DIVISION, DEPARTMENT OF PERSONNEL & TRAINING, BLOCK-IV, 3<sup>rd</sup> FLOOR (Room No. 310), JNU(OLD) CAMPUS, NEW DELHI-110067 within a period of 60 days from the date of publication of this advertisement in the Employment News/Rozgar Samachar.
- 3. Applications of only such officers/candidates will be considered as are routed through proper channel and are accompanied with (i) Bio-data (in quadruplicate) in the proforma given in Annexure-II (ii) Attested photocopies of ACRs/APARs for the last five years(ACRs/APARs to be attested by an officer not below the rank of Under Secretary) (iii) Vigilance clearance (Annexure-III) (iv) Statement giving details of major or minor penalties imposed on the officer, if any, during the last ten years as given in Annexure-IV (v) Integrity certificate (Annexure V) and (vi) Cadre Clearance.

- 4. Applications received after the closing date or without the prescribed documents or otherwise found incomplete or not in the prescribed proforma are liable to be rejected. Officers who apply for the post will not be allowed to withdraw their candidature subsequently.

- (ii) with five years' service in the grade rendered after appointment thereto on regular basis in pay band-3, Rs. 15,600-39,100 plus grade pay of Rs 5400 or equivalent in the parent cadre or Department; or
- (iii) with six years' service in the grade rendered after appointment thereto on regular basis in pay band-2, Rs. 9300-34,800 plus grade pay of Rs. 4800 or equivalent in the parent cadre or Department; and

## Essential:

- (i) Bachelor's Degree from a recognised University; and

For Armed Forces Personnel:- Deputation/Re-employment Armed Forces Personnel in the rank of Major or equivalent in Indian Army, Indian Navy or Indian Air Force in the pay band -3, Rs. 15600-39100 plus grade pay of Rs. 6600, who are due to retire or to be transferred to reserve within a period of one year and have the qualifications and experience prescribed for deputationist shall also be considered. If selected, such officers will be given deputation terms up to the date of which they are due for release from the Armed Forces; thereafter they may be continued on Re-

employment terms. In case such eligible officers have retired or have been transferred to reserve before the actual selection to the post is made their appointment will be on re-employment basis (Re-employment upto the age of superannuation with reference to civil posts)]

Note:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the 6th Central Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay or pay scale, and where this benefit will extend only for the post for which that grade pay or pay scale is the normal replacement grade without any upgradation.
