#### THE INSTITUTE :

HRI is a premier Institute dedicated to high level theoretical basic research in mathematical and physical sciences. It is a grant in aid autonomous institution under DAE and is widely recognized for its excellence in scientific research. The Institute has major programmes in several areas in mathematics including number theory, and in astrophysics, condensed matter physics, particle, physics, quantum information, and string theory.

# THE JOB/RESPONSIBILITIES :

Director, HRI should be an eminent scientist/mathematician of international repute who can command respect of peers both within and outside the Institute. He/she will be the Chief Executive of the Institute and would be accountable to the Governing Council of the Institute. He/she would be responsible for all the activities of the Institute in the pursuit of its goals and objectives. He/she would be required to closely co-ordinate with other constituent units of the DAE and other Government Departments, Educational Institutions etc., in the execution of the Institute's projects and contracts.

# THE PERSON :

HRI requires a person of outstanding professional competence and proven managerial ability. He/she should possess the necessary capabilities for management of the institution including its scientific programmes, research infrastructure, personnel management, financial management and project management. He/she should have the required conceptual ability and qualities of leadership to direct a multi-disciplinary team to achieve the objectives of the Institute.

#### PAY SCALE :

The post of Director, HRI carries pay in the HAG + Scale of Rs.67000-(annual increment @ 3%) – 79000.

#### ELIGIBILITY :
