OFFICE MEMORANDUM

Subject: Selection for the posts of Members in the Customs and Central Excise Settlement Commission – Reg.

Some vacancies in the post of Member, Customs and Central Excise Settlement Commission are likely to arise at various locations of the Commission, as per the details given below:-

S.No.	Date of Vacancy	Place of Vacancy
1	05.10.2015	Kolkata Bench
2	On or after 12.03.2016	Consequential vacancy upon appointment of one of the Member as Chairman, Customs and Central Excise Settlement Commission
3	30.05.2016	Chennai Bench

In addition to the above, any unforeseen vacancy or residual vacancy against the vacancy circular dated 07.09.2015, if any, that occurs till 30.09.2016 will also be covered by this vacancy circular.

2. As per the Customs and Central Excise Settlement Commission (Recruitment and Conditions of Service of Chairman, Vice-Chairman and Members) Rules, 2015, Chief Commissioners or Principal Chief Commissioners or Principal Commissioners of Customs and Central Excise or officers of equivalent rank **who are in service on the date of occurrence of the respective vacancy shall be considered qualified for appointment as Member, Settlement Commission against the respective vacancy.** Once appointed, the Members of the Commission shall serve the Commission at least for two years before they are appointed to any new assignment. The existing Recruitment Rules may be accessed from the website of the Department of Revenue (dor.gov.in→Acts and Rules).
3. **The applicant shall not be allowed to change his/her preferences/options of posting after the closing date of inviting the applications or withdraw his/her candidature after the meeting of the Selection Committee.**
4. **In case the applicant is considered and selected for appointment by the ACC, he/she should not decline the appointment. If he/she declines the appointment or do not join within 30 days of the order of appointment, he/she will not be considered for any further appointment outside his/her cadre for three years and also be debarred for consideration for appointment outside the cadre and in any Autonomous Body/Statutory Body/Regulatory Body for a period of three years. No further notice in this regard will be given.**

5. All eligible and willing officers may be requested to submit their applications through proper channel by **04.04.2016** in the prescribed proforma (Annexure) to :-

6. Applicants may be advised to indicate their preferences for places of posting, if any, in descending order of preference. If preference for a particular location has not been indicated but preference for other locations have been shown, it will be presumed that the applicant does not wish to be appointed there. If any location has not been indicated at all, it will be presumed that the applicant has equal preference for all locations. The place of posting of a Member of the Commission shall not be determined only on the basis of his/her prior preference. **Applications received after the closing date shall not be entertained.**
