This is regarding filling up of the post of Member (Personnel) in the Prasar Bharati Board. The Prasar Bharati Board is vested with the powers of general superintendence, direction and management of Prasar Bharati {Broadcasting Corporation of India (BCI)}, established under the Prasar Bharati (BCI) Act, 1990.

2. Appointment to the post of Member (Personnel), Prasar Bharati Board is made by the President of India on the recommendation of a Selection Committee headed by the Vice President of India as Chairperson, the Chairman, Press Council of India as Member and one Member nominated by the President of India. A person having special knowledge or practical experience in respect of personnel management and administration can be considered for appointment to the post of Member (Personnel), Prasar Bharati Board. A person appointed as Member (Personnel) shall be the Whole-time Member of the Prasar Bharati Board and shall hold the office for a term of six years from the date on which he/ she enters upon his/her office, or until he/she attains the age of sixty two years, whichever is earlier. The post of Member (Personnel) carry the scale of pay equivalent to that of Additional Secretary to the Government of India.

3. The terms and service conditions of the Member (Personnel) shall be governed by the Prasar Bharati (BCI) Act, 1990 and the Prasar Bharati (BCI) Salaries, Allowances and other Conditions of the Service of Chairman, Whole-time Members and Part-time Members Rules, 2000 and the amendments issued therein from time to time. Subject: Appointment of Member (Personnel) in Prasar Bharati.

The Ministry of Information & Broadcasting invites applications from eligible persons for consideration for appointment to the post of Member (Personnel) in Prasar Bharati (Broadcasting Corporation of India), a Corporation set up by an Act of the Parliament {The Prasar Bharati (Broadcasting Corporation of India) Act, 1990} and hereinafter referred to as Prasar Bharati. The post carries scale of pay equivalent to the Additional Secretary to the Govt. of India. The post has been vacant w.e.f. 17.02.2014.

The President of India appoints a person having special knowledge or practical experience in respect of personnel management and administration to the post of Member (Personnel), Prasar Bharati Board on recommendation of a committee headed by the Vice President of India. The person so appointed being the whole time member of the Prasar Bharati Board shall be an employee of the Prasar Bharati and shall hold office for a term of six years from the date on which he/she enters upon his/her office, or until he/she attains the age of sixty two years, whichever is earlier.

Job Description and Responsibilities

The Member(Personnel) shall be a whole time Member of the Prasar Bharati Board and in pursuance of the Prasar Bharati Act, 1990, will be responsible for all the personnel and administrative matters concerning the Prasar Bharati. The Prasar Bharati Board is vested with powers for overall superintendence, direction and control of the affairs of the Corporation.

Terms and Conditions of Service

The service conditions of the Member (Personnel) shall be governed by the provisions of the Prasar Bharati Act, 1990 and the rules notified by the Government of India, titled as the Prasar Bharati (Broadcasting Corporation of India) Salaries, Allowances and other Conditions of Service of Chairman, Whole- time Members and Part-time Member Rules, 2000 and the amendments

issued therein from time to time. The Act and the Rules are available in the website of the Ministry of Information & Broadcasting, www.mib.gov.in/ Acts & Rules/Broadcasting-Acts & Rules/Prasar Bharati.

Qualification and Experience

For applicants from private sector/autonomous bodies/statutory corporation

The applicant should be a graduate from a recognized university/institution with good academic record. Persons possessing MBA qualification in Personnel Management would be preferable. He should possess adequate post qualification experience at a senior level of management in a large organization of repute.

For applicants from Public Sector Enterprises

Senior Executive /Board Level Executive working in reputed Public Sector Enterprises, willing to get absorbed in the Prasar Bharati.

For applicants from Govt.

Additional Secretary/Senior Joint Secretary level officers who are willing to get absorbed in Prasar Bharati on selection.
