Sir,

I am directed to say that it is proposed to fill up the posts which will fall vacant shortly, in the Central Electricity Authority (CEA), on deputation/short-term contract basis:

- (i) Member (Grid Operation & Distribution)
- (ii) Member (Hydro)
- 2. The post of Member in the Central Electricity Authority carries the scale of pay of Rs.22400-525-24500/- (Pre-revised) [Rs.67000-79000 (Revised)] with ex-officio status of Additional Secretary to the Government of India. The incumbent of the post is entitled to other allowances/benefits as per rules of the Central Government.
- 3. Appointment to the post of Member in the Central Electricity Authority is being made in accordance with the provisions contained in Section 70 of the Electricity Act, 2003 read with the Central Electricity Authority (Terms and conditions of Service of Chairperson and other Members) Rules, 2005.
- 4. Section 70 (5) of the Electricity Act, 2003 provides that the Members of the Authority shall be appointed from amongst persons of ability, integrity and standing who have knowledge of, and adequate experience and capacity in, dealing with problems relating to engineering, finance, commerce, economics or industrial matters, and at least one Member shall be appointed from each of the following categories, namely:
 - (a) engineering with specialization in design, construction, operation and maintenance of generating stations;
 - (b) engineering with specialization in transmission and supply of electricity;
 - (c) applied research in the field of electricity;
 - (d) applied economics, accounting, commerce or finance.

- 5. In terms of the provisions contained in the Central Electricity Authority (Terms and conditions of Service of Chairperson and other Members) Rules, 2005, no person shall be eligible for appointment to the office of a Member, including the Chairperson of the Authority unless he has held:
 - the post of Chief Engineer or equivalent in the scale of pay of Rs.18400-500-22400 (prerevised) [Rs.37400-67000 + Grade pay of Rs.10000 (Revised)] or higher post or scale of pay on a regular basis for at least five years under the Central Government or a State Government;

or

a post equivalent to that of a post mentioned above, under a State Electricity Board or a semi-Government Organisation or a Public Sector Undertaking or an Autonomous Body or a Statutory Body or a University or an Indian Institute of Technology or an Indian Institute of Management on a regular basis for at least five years; and

- (b) The person would also need to possess a minimum of three years' field experience in the relevant field as defined in sub-section (5) of section 70 of the Electricity Act.
- 6. The duties and responsibilities attached to the posts of Member (Grid Operation & Distribution) and Member (Hydro), CEA, is given in the <u>Annexure-I.</u>
- 7. The Chairperson and Member shall hold office during the pleasure of the Central Government. Appointment to the post would normally be made for a period of five years, which shall be restricted to the date on which the incumbent of the post attains the age of superannuation. The officer selected will not be eligible for permanent absorption in the CEA. The maximum age limit for appointment to these posts shall be **58 years** on the closing date of receipt of application.
- 8. The crucial date for determination of eligibility of applicants for the posts will be the closing date for receipt of the applications.
- 9. It is requested that the above vacancies may be given wide publicity amongst the eligible candidates and the particulars of the suitable and eligible serving persons who are willing to be considered and whose services can be spared, may please be forwarded in the enclosed Proforma (Annexure-II) (in quadruplicate) (if applying for more than one post, separate application for each post) together with the following documents/information so as to reach within 45 days from the date of publication of the vacancy in the Employment News/Rozgar Samachar, to the Under Secretary (Admn). Ministry of Power, Room No.26, Shram Shakti Bhawan, Rafi Marg, New Delhi-110001:
 - (i) Attested photocopies of Annual Confidential Reports for the last 5 years.
 - (ii) Vigilance Clearance Certificate & Integrity Certificate (to be signed by an officer not below the rank of Deputy Secretary to the Government of India.
 - (iii) Whether any penalty has been imposed on the applicant in the last ten years, and if so, details thereof.

Formulation of policies for safe, secure and economic operation of regional grids; integrated operation, control and co-ordination of five regional grids through Regional Power committees; monitoring of delivery of shares from Central Sector projects; intra and inter-regional exchange of power; emergency power assistance; energy accounting on daily and monthly basis; load generation balance and grid disturbance studies; grid code; tariff principles of bulk generation & transmission; monitoring of rural electrification; optimization of distribution network; work relating Accelerated Power Development & Reforms Programme (APDRP) including 100% metering, energy accounting, evaluation of benefits, quality control; matters relating to telecommunication in Power Sector; telecommunication data acquisition and software support; operation monitoring and performance review of thermal power stations; updating of maintenance procedures; generation data collection; performance analysis; maintenance monitoring etc.
