MINIMUM ELIGIBILITY REQUIREMENTS

Traffic Manager and equivalent posts in Traffic Department in the scale of pay of Rs.32900-58000 (pre-revised Rs. 16000-20800) and above with 5 years regular service in the grade in Govt./ Semi- Govt./PSUs or Autonomous bodies will be eligible. The selection is by merit for which the benchmark in overall grading in the ACRs will not be below "Very Good".
- 2.1 The applicant should have at least four years' service left for retirement in the present organization for deputation posting.
- 2.2 Benefits admissible include DA on IDA pattern and other allowances with monthly gross remuneration of about Rs.1,31,328 plus HRA at 30% (of basic) in case not residing in Port's accommodation.
