The pay of the officers selected for appointment on deputation basis as well as other conditions related to their deputation will be regulated in terms of DoPT's O.M. Nos. 6/8/2009-Estt.(Pay II) and 2/6/2016-Estt.(Pay-II) dated 17.06.2010 and 17.02.2016 respectively, as amended from time to time.

- 2. Applications of only such Officers will be considered as are routed through proper channel and are accompanied by:
- (i) Bio-data (in duplicate) as per proforma (Annexure-I);
- (ii) Photocopies of APARs for the last five years, attested (signed & stamped) on each page by an officer not below the rank of Under Secretary to the Government of India level;
- (iii) Vigilance clearance Certificate (Annexure-II);
- (iv) Integrity Certificate (Annexure-III)
- (v) No Penalty Certificate or a statement giving details of major/minor penalties imposed, if any, on the officer during the last 10 years (Annexure-IV); and
- (vi) Cadre Clearance Certificate, in the enclosed format (Annexure-V). It may also be verified and certified that the particulars furnished by the officers are correct.

- 3. The period of deputation, including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Department/Organisation of the Central Government, shall ordinarily not exceed five years.
- Applications not received through proper channel or received after the last date or incomplete in any respect such as those not accompanied by the documents mentioned at para 2 above, will be liable to be rejected.

Similarly, deputationists shall not be eligible for consideration for appointment by promotion. The crucial date for determining eligibility will be the last date for receipt of the applications.
