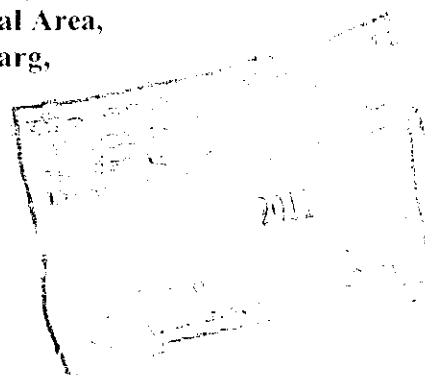
**SUBJECT: NOTICE INVITING APPLICATIONS FOR APPOINTMENT OF  
THE VICE-CHANCELLOR OF THE VIDYAPEETHA**

Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University) is a Central Autonomous Body which is fully funded by the UGC and functions under the administrative control of the Government of India, Ministry of Human Resource Development (Department of Higher Education). This NAAC accredited premier institution of higher learning is located on 10.5 acres of land at Qutab Institutional Area in the southern part of Delhi. In this esteemed institution, the post of Vice-Chancellor has fallen vacant since 11th July, 2011 which needs to be filled up expeditiously. Accordingly, applications are invited for appointment of the Vice-Chancellor of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi on a fixed pay of Rs.75000/- p.m. along with a Special Allowance of Rs.5000/- per month and other allowances as admissible under the UGC/GOI guidelines. He shall be entitled to such facilities as per the rules of the Vidyapeetha.
