- 2. The numbers of Consultants to be engaged are tentative and the same may be increased or decreased as per requirement of NRA or reserves the right to even cancel the notification. The remuneration of Consultants will be as per extant Rules and Instructions of the Government of India.
- 3. The candidates must have retired as Under Secretary/Section Officer/AAO/AO or equivalent and must have experience in the field of administration/Audit & Accounts and in general working of the Government. The Consultant should have working knowledge of MS Office, Computer handling & Internet Browsing. Age not exceeding 65 years as on closing date for receipt of applications. However, in the deserving cases, age can be relaxed up to 70 years.
- 4. Method of Selection: The engagement will be purely on contract basis. Shortlisted candidates will be called for interview by the Selection Committee. The selected candidates would be engaged as Consultants as per the requirement of the NRA.
- 5. The terms and conditions of their appointment will be as follows: -
- (a) The terms of appointment shall ordinarily be for an initial period not exceeding one (1) year, which is extendable up to one (1) more years as per requirement of NRA.
- (b) The consultant shall maintain integrity and confidentiality with the Government of India and would be required to sign a non-disclosure as per Annexure-I.
- In terms of Department of Expenditure OM No.3-25/2020-E.IIIA dated 09.12.2020 a fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of the retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. No increment and Dearness Allowance shall be allowed during the term of the contract.

- (d) The Income Tax or any other tax will be deducted at source as per the Government instructions. Necessary TDS Certificate will be issued to them.
- (e) They shall not be entitled for prerequisite such as HRA, CCA, residential accommodation, etc. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the consultant at the time of retirement.
- (f) No TA/DA would be admissible to them for joining the assignment or on its completion.
- (g) During the period of consultancy, the Consultants would be required to attend all important items of work pertaining to NRA as assigned from time to time.
- (h) During the period of their assignment with the NRA and also thereafter, it is likely that they may come across certain information of important/confidential nature. They will not divulge any information gathered by them during the period of their assignment to anyone who is not authorized to know/have the same.
- (i) Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of consultancy. Accumulation of leave beyond a calendar year will not be allowed.
- (j) The Consultant shall be required to observe the normal office timings and may also be called upon to attend the office on Saturday/Sunday closedholidays/beyond working hours in case of exigencies of work.
- (k) NRA reserves the right to select or reject a candidate or terminate the contract without assigning any reason at any time
